

**STATE BOARD OF FINANCIAL INSTITUTIONS**  
**MINUTES**  
**February 5, 2014**  
**Columbia, South Carolina**

Upon proper call and due notice to all of its members and after having given required public notice, the State Board of Financial Institutions assembled in a meeting this the 5th day of February 2014, with Chairman Curtis M. Loftis, Jr. presiding. Members present were: Messrs. Apple, Conley, Hart, Hassell, Pennington, Saunders, Williams, Wright, and Ms. Marcum. Absent was Mr. Anderson. On motion of Mr. Hassell, duly seconded by Mr. Wright and unanimously carried, the Board approved minutes from the January 8, 2014 meeting.

#### Examining Division

On motion of Mr. Conley duly seconded by Mr. Apple and unanimously carried, the Board approved the request of approving the extension of State chartered banks to hold other real estate for up to an additional five year period as provided by Regulation 15-26 subject to action by the Commissioner of Banking, although the Commissioner of Banking may in his own judgment bring any individual request pursuant to Regulation 15-26 to the Board for its consideration. The Commissioner will give monthly reports on these approvals.

On motion of Mr. Hassell duly seconded by Ms. Marcum and unanimously carried, the Board approved the request of Enterprise Bank of South Carolina, Ehrhardt, to amend its articles of incorporation to increase its authorized and outstanding stock.

#### EXECUTIVE SESSION

On motion of Mr. Hart duly seconded by Mr. Williams and unanimously carried, the Board voted to go into Executive Session to receive and discuss information pertaining to examinations of institutions required to be made by law, trade secrets, information regarding contractual arrangements, purchase of property, examination findings and receive legal advice.
